The Rotary Service Public Charitable Trust under its "Mahavir Prasad Ruia Loan Scholarship" project offers Interest Free Loans to needy students of Mumbai for Vocational and Professional studies to meritorious students. These need based loans are generally considered and are to be repaid after graduation within 2-3 years period and in easy monthly Installments details. Please study the following guidelines and if eligible contact the Rotary Service for application form.

**Guidelines**

- Community : Needy students from low income group and family income below Rs. 3 lakh qualify for the loan scholarship if they live in Mumbai and or study in Mumbai (upto Virar), Navi Mumbai or Thane.
- Minimum Education : S.S.C. or H.S.C. as applicable for the selected course with a minimum of 60% marks
- Courses : Vocational or professional courses leading to a certificate, diploma or degree in the Following type of courses will qualify for the loan scholarship.
- ★ Engineering – Diploma, Degree
  - ★ Advertising
  - ★ Education
  - ★ Business Management (post graduate)
  - ★ Craftsman Courses – Turner, Draftsmen, Plumber, Wiremen, etc.
  - ★ Tourism, Catering, Hospitality etc.
  - ★ Commercial Arts
  - ★ Computer courses
  - ★ Any other vocational course
- Amount : The loan shall be granted to the maximum extent possible.
- Repayment : Full repayment in monthly installment within two years but not later than three years after completion of course and after securing gainful employment

**Note** : The decision of Rotary Service Public Charitable Trust shall be final
